## ORDINANCE NUMBER 2022-7A

## AN ORDINANCE RELATING TO COMPENSATION

WHEREAS, The Illinois Municipal Code provides that the Mayor and the Board of Trustees of the Village of Roseville, Illinois shall receive a salary set by ordinance (65 ILCS 5/3.1-50-5), and

WHEREAS, The Illinois Municipal Code provides that the salaries or other compensation shall not be increased or diminished so as to take effect during the term of any officer holding an elective office, (65 ILCS 5/3.1-50-5), and

WHEREAS, The Illinois Municipal Code provides that the salaries or other compensation shall not be diminished so as to take effect during the term of any officer holding an appointed office, (65 ILCS 5/3.1-50-5), and

WHEREAS, The Illinois Municipal Code provides that the salaries or other compensation that are fixed at least 180 days before the beginning of the terms of the officers who hold elective office for a definite term whose compensation is to be fixed,

NOW, THEREFORE, BE IT ORDAINED BY THE ACTING MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ROSEVILLE, ILLINOIS:

Section One. The salary of the Mayor, or acting Mayor, shall be increased \$250.00 per month from \$500.00 per month to \$750.00 per month. This increase shall become effective upon the completion of the current term of office for the position of Mayor.

Section Two. The salary of the Treasurer shall be increased \$250.00 per month from \$340.00 per month to \$590.00 per month. This increase shall become effective immediately.

Section Three. The salary of a Trustee shall be increased \$250.00 per quarter from \$375.00 per month to \$620.00 per month. This increase shall become effective upon the completion of the current term of office for each Trustee position.

Section Four. This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
